NATIONALITY OF THE PARTIES



In 2023, parties from more than 14 countries have participated in the arbitration, including: Brazil, Bolivia, the United States, Spain, Ecuador, France, Italy, the Netherlands, Luxembourg, Mexico, Morocco, Switzerland, Tunisia and the Czech Republic.




46% of the cases have been handled in **english** and **54%** in **spanish**






DESIGNATIONS BY GENDER






GENDER DESIGNATIONS BY THE CENTER

DIRECT DESIGNATIONS






Choice of parties after ranking of candidates.




DESIGNATIONS BY NATIONALITY



APPOINTMENT BY THE PARTIES






DESIGNATIONS BY NATIONALITY BY LIST SYSTEM




APPOINTMENT AFTER RANKING
OF CANDIDATES




DESIGNATIONS BY AGE

CONCLUSIONS

- The CIAM ends the year with **35 cases**, 15 of them with an entry in 2023.
- Almost 25% of the cases belong to the "**Corporate**" sector, followed by almost 20% of the cases in the "**Professional Services**" sector and 12% in the "**Construction**" sector.
- Among the parties, **14 different nationalities** stand out and arbitrators of **8 different nationalities** have been appointed.
- In relation to gender:
 - In appointments by the parties, **50% women and 50% men** have been appointed.
 - In direct appointments by the Center, **43% were women and 57% men**.
 - In appointments by list, **100% men** were appointed (although the lists proposed to the parties by the Center contained **60% women**).
